**Wind4All Communities IV Inc. – New CEDIF Offering Now Open.**

Wind4All Communities IV (Wind4All) is the latest installment in the Wind4All family of companies to launch its CEDIF offering, providing a new opportunity for Nova Scotians to invest in the province's booming wind industry.

Between now and late December, and through its CEDIF offering, Wind4All will seek to raise up to \$3 million, the net proceeds of which will be used to invest in the Barrachois Community Wind Farm, located in the CBRM, 15 km west of Sydney. The investment returns are comprised of both equity tax credits (up to 65% of the initial investment)<sup>1</sup> and dividends paid out by Wind4All.

The project has been awarded COMFIT approval by the Department of Energy. It has a 20 year Power Purchase Agreement secured with Nova Scotia Power, and is in fact already under construction. The first power production is expected to come in Q2 of 2015.
